Agency Updates (DOC, SCC, DCYF) Eastern WA DOH Advisory Committee Treasury Membership Program Committee SOPB/ legislative updates

- The board voted unanimously to appoint Jason Bailey to the vacant general board position. His appointment will end on 12/31/23 and he will need to enter the election and be voted in by membership.
- Getting very close with insurance policies.

DOH Advisory Committee: No new updates.

<u>DOC Update (B. Borg)</u>: DOC is nearly back to functioning at pre-COVID levels. They are nearly fully staffed. The biggest challenge is getting clients into treatment in a timely manner.

<u>SCC Update (M. Reese)</u>: A. Radosteva was hired into the Chief of Clinical Services position which will be helpful in spreading the workload. They are planning on adding more specialty groups. There is a new liaison to Pierce College who is helpful in sharing what opportunities are available for residents. They are working on changing the law enforcement policies and procedures around community notification of residents being released on LRA.

<u>DCYF Update (J. Pelander)</u>: They are working on finalizing juvenile registration laws and communicating this to staff. All juveniles convicted of a sexual offense on 7/23/23 or later will have required JRA supervision. They will be doing reentry planning with all juveniles releasing to the community. There is a grant available of \$140,000 to the juvenile courts for treatment programming. Between 11/1 and 12/1 all juveniles on the registry will receive notification from the sheriff they have been removed.
