### Agenda

- 1) Ken Schafer and Florence have stepped down from the Board.
- 2) Priscilla Hannon has accepted to be the Eastern Washington WATSA representative.
- 3) The Static/ STABLE/ ACUTE training was a success, yielding a profit of \$1,690.68. The Board voted to make a \$500 donation to KCSARC as they allowed us to use their space at no charge.
- 4) The Chaperone training received good feedback. A loss of \$16.72 was reported.
- 5) WATSA is offering CEUs for attendance at the Sex Offender Management Conference. The coordinators of the conference will keep track of who is attending each session by having people scan their badges in and out. Conference attendees can pay \$20 for the CEUS.
- 6) The Board is working on moving accounts from Key Bank to Chase Bank.
- 7) Holly has been working closely with Ted Dale from DOH. She forwarded an outline of the certification process used in California for Mr. Dale to review and she plans to follow up next week.
- 8) Conference 2018
  - a. There was a net loss of \$5,605.73 from the conference this year. The bulk of the loss came from having fewer attendees and needing to cover the cost of the unused rooms in the room block.
  - b. The evaluations from the conference were positive overall but attendees would like more treatment-related topics.

1) Retreat update

2) Conference 2019

- a. Maureen and another Board member will meet with the event people at Suncadia to see if we can cut costs.
